

**ASC 2026 Bullseye League**  
**NRA Approved Outdoor Conventional Pistol League**  
**Sponsored by the Aurora Sportsmen's Club**  
**Waterman, IL**

**Fourth Saturday of each month 4/25/2026 – 10/24/2026**

**Who May Compete:** Open to all ASC members and invited guests.

**Range Location:** 1 mile south of Waterman, IL, on Rueff Road between Leland and Waterman Roads.

**Registration Fee:** Annual League Registration fee is \$40.00. Juniors may choose to compete as part of the approved league (all fees apply), or, positions permitting, they may compete “for fun”. “For fun” Juniors will be charged an annual fee of \$20 and scores will not be submitted to NRA.

**Monthly Match Entry Fee:**

- ASC members: \$5 per relay
- Guests: \$10 range fee per day + \$5 per relay
- League Juniors: \$5 per relay. There is no monthly fee for Juniors competing “for fun”.

**Entries:** Entries will be limited to 40 competitors per relay. Priority will be given to League shooters.

**Registration:** Generally, a call for relay reservations will be sent via email the Monday before each monthly match. Reservations are first-come, first-served through reply email. Reservations may be made by contacting [bullseye@aurorasc.org](mailto:bullseye@aurorasc.org). Walk-ins are welcome, but firing positions will be assigned on an availability only basis.

**Time:**

**Rules:** Current NRA rules will govern all firing. It is the competitor’s responsibility to be familiar with such rules as well as those imposed by the Match Director. Competitors will score and change targets. Bring your stapler. Only ASC rules will apply to “for fun” Junior shooters.

**Equipment:** .22 Caliber Pistol or Revolver; Center Fire Pistol or Revolver (NRA Conventional Pistol Rules, sections 3.4 and 3.2, respectively). Eye & ear protection is required.

**Challenges:** Challenge fee is \$2.00. A jury system will be used. Plug-type scoring gauges will be restricted to range personnel only.

**Classification:** NRA classification system will be used for the end-of-league championship only. No classifications will be used for the monthly matches (a handicap system will be used for the monthly matches).

**Categories:** All adults will compete as league participants. Juniors may choose to compete in the league, or “for fun”. For 2026, a “Junior” is anyone born on or after 1/1/2007.

**Facilities:** 40 firing points. Firing line is tables under cover on gravel. Targets are rotating. Pit toilet and port-a-potties nearby. Water will be available for purchase. A BBQ Brat/Polish lunch will be available for purchase at the range.

**Handicap system:** Monthly match results will be based on a handicap point system. Each person's handicap will be 90% of the difference between 810 and their average of the previous three matches. Handicaps are maintained on a per match-gun basis (.22 and CF).

### **Course of Fire: (3 x 900)**

Three independent relays of 90 shots each will be offered each month. A shooter may choose to shoot any 1, 2 or all three relays. The first relay will be limited to .22 only. Relays 2 and 3 will be open to any gun. The first relay a shooter fires with .22 and the first relay a shooter fires with CF will count as the monthly match score.

Each 900 relay will consist of:

- 20 shots Slow Fire (two targets, 10 shots each), at 50 yards, B6 target
- 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- 20 shots, Timed Fire, at 25 yards, B8 target
- 20 shots, Rapid Fire, at 25 yards, B8 target

### **Awards:**

Monthly match awards for each gun will be determined by handicapped scoring and will be honorific only (no cash or other awards):

End of league championship (non-handicapped scoring)

- Uses NRA classification
- Best four monthly .22 scores + best four monthly CF scores
- 1<sup>st</sup> place in each NRA classification: Trophy
- 2<sup>nd</sup> place in each NRA classification (if 5 or more qualified shooters): Trophy or Medal
- 1<sup>st</sup> place Junior (in league): Trophy
- “For fun” Juniors – no awards

### **Other:**

- Makeup and pre-makeup matches are permitted for league championship determination.
- At the completion of all league shooting, all scores fired during league shooting will be submitted to the NRA for use in calculating a shooter's classification (i.e. a minimum of one fired match is required to submit scores.)
