# NRA Approved 2700 Precision Pistol Match and CMP EIC Pistol Matches Sponsored by the Aurora Sportsmen's Club - Waterman, IL

Saturday, September 20, 2025

Who May Compete: Open to all ASC members and invited guests.

**Range Location:** 1 mile south of Waterman, IL, on Rueff Road between Leland and Waterman Roads.

**Registration Fee:** Registration fee is \$10.00, of which \$4.50 goes to the NRA.

**2700 Match Entry Fee:** \$2.50 per match. Across the board for all 2700 matches, including registration fee, is \$45.00.

**EIC Match Entry Fee:** \$20 per match, \$15 of which goes to the CMP (note, EIC match will be held only if there are at least 6 non-distinguished competitors registered).

**Entries:** Entries will be limited to 40 competitors. Across the board entries will be given preference in entry.

**Rules:** Current NRA/CMP rules will govern all firing. It is the competitor's responsibility to be familiar with such rules as well as those imposed by the Match Director. Competitors will score and change targets. Bring your own stapler.

**Challenges:** Challenge fee is \$2.00. A jury system will be used. Plug-type scoring gauges will be restricted to range personnel only.

**Equipment:** Eye & ear protection is required.

- NRA 2700: NRA Precision Pistol Rules, section 3 for open division.
- **EIC Service Pistol Match:** CMP Competition Rules, sections 4.1.
- CMP .22 Rimfire Pistol EIC Match: CMP Competition Rules, 4.1.6
- **CMP Service Revolver EIC Match:** CMP Competition Rules, 4.1.7

**Classification:** NRA classification system will be used for the NRA 2700. Unclassified competitors will fire in the master class.

**Categories:** For the NRA 2700, shooters will be grouped per NRA classification. Classes with less than 5 shooters will be grouped with the class above (Masters with Match Winner class).

**Facilities:** 40 firing points. Firing line is tables under cover on concrete. Sustained fire targets are rotating. Port-a-potties near the firing line, bathroom facilities available a short distance away. Water will be available. A BBQ Brat/Polish lunch will be available for purchase at the range.

- Match 1: 22 caliber, 20 shots, Slow Fire, at 50 yards, B6 target
- Match 2: 22 caliber, 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- Match 3: 22 caliber, 20 shots, Timed Fire, at 25 yards, B8 target
- Match 4: 22 caliber, 20 shots, Rapid Fire, at 25 yards, B8 target
- Match 5: Aggregate of matches 1, 2, 3, and 4.
- Match 6: Center Fire, 20 shots, Slow Fire, at 50 yards, B6 target
- Match 7: Center Fire, 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- Match 8: Center Fire, 20 shots, Timed Fire, at 25 yards, B8 target
- Match 9: Center Fire, 20 shots, Rapid Fire, at 25 yards, B8 target
- Match 10: Aggregate of matches 6, 7, 8, and 9.
- Match 11: .45, 20 shots, Slow Fire, at 50 yards, B6 target
- Match 12: .45, 30 shots, NMC (10 shots SF at 50 yards, 10 shots TF at 25 yards, 10 shots RF at 25 yards).
- Match 13: .45, 20 shots, Timed Fire, at 25 yards, B8 target
- Match 14: .45, 20 shots, Rapid Fire, at 25 yards, B8 target
- Match 15: Aggregate of matches 11, 12, 13, and 14.
- Match 16: Grand Aggregate Aggregate of matches 5, 10 and 15.
